PGA/USPTA Junior Golf and Tennis Summer Academies

It's time to make plans once again for the 2021 Suntree Junior Summer Academies. The Golf and Tennis Academies will be held throughout the summer to offer a complete day program that will include professional golf and tennis instruction each day from 9:00 a.m. to 3:30 p.m. Any Suntree golf, tennis or social member will have priority for signing up for the Academies. The grandchildren of Suntree members are also encouraged to attend.

Beginning Camp Tuition (all prices have tax included)

\$306.02 for the weeklong academy to include 4 half days of golf and 4 half days of tennis (Golf and Tennis from 9:00 to 3:30 p.m.)

\$194.74 for a ½ day program of golf 9:00-11:30 a.m.

\$175.48 for a ½ day program of Tennis 1:00 – 3:30 p.m.

***If space is available, guests can participate at a cost of \$347.75 for each session and \$230.05 for a 1/2day program of golf or \$206.51 for afternoon tennis.** Those children attending the all-day program will be served lunch between 11:45 -1:00 p.m. Supervised swimming will also be available during the lunch break for those interested. (Please bring necessary swimwear and towel).

Advanced Camp Tuition (all prices have tax included)

\$230.05 for a ½ day advanced camp (must be able to play 9 holes without adult supervision). ***If space is available, guests can to participate at a cost of \$277.13 for each session.**

Beginning Camp Curriculum

The Golf Academy will include instruction from the PGA Golf Professional staff. This will include time on the practice range, covering the fundamentals of the game (grip, aim, stance, posture and full swing drills). Later sessions will cover pitching, chipping, sand shots and putting? Golf etiquette and rules will be stressed throughout the academy. Each participant in the Golf Academy will receive an achievement certificate, fruit, cookies and drinks at scheduled break intervals. Also, every child will receive a Suntree Golf and Tennis Academy gift. If your junior golfer does not own clubs, clubs will be supplied at no charge.

Advanced Camp Curriculum

PGA Golf Program

The Golf Academy will include instruction from the PGA Golf Professional staff. This will include time on the practice range, covering the fundamentals of the game (stance, grip and full swing drills). Later sessions will cover pitching, chipping, sand shots and putting? Golf etiquette and rules will be stressed throughout the academy. Each participant in the Golf Academy will receive a rulebook, an achievement certificate, fruit, cookies and drinks at scheduled break intervals. Also, every child will receive a Suntree Golf and Tennis Academy gift. If your junior golfer does not own clubs, an iron and a wood will be available for their use in the Junior Academy.

USPTA Tennis Program

The Tennis Academy will include instruction from the USPTA certified professional staff. It also includes hand-eye coordination drills, hitting drills, footwork drills, supervised match plan and plenty of fun! Racquets and sunscreen are also available to juniors who need them. Participants in the Tennis Academy will receive a certificate, fruit, cookies and drinks at scheduled break intervals and a Suntree Golf and Tennis Academy gift.

The Dress Code

Clothing should be appropriate for a private country club. Every junior and parent will be expected to follow the guidelines of the Suntree membership. No sandals or flip-flops. Suntree Country Club's Professional Staff are experienced in junior golf and tennis instruction and will teach your child the fundamentals and traditions of the game.
